Auditor's Limited Review Report

We have reviewed the accompanying statement of unaudited standalone financial results ("the Statement") of **Morning Glory Leasing And Finance Limited** ("the Company") for the quarter ended 31st December, 2023 and year to date results for the period 1st October, 2023 to 31st December, 2023.
